The Nebraska Mortgage Association seeks to recognize and celebrate the service, dedication, and hard work that leading mortgage professionals put into serving their clients during the home loan process.

The Champions Circle consists of mortgage originators who meet certain criteria set each year, based on the location/population of the originator. The originator must submit their entry form **on the NMA website**, providing verification of volume to the selection committee. Qualifying members of the 2018 Champions Circle will be honored at the Industry Lunch at the NMA 2018 Annual Fall Conference, September 18 at the Scott Conference in Omaha. (Must be preregistered for the conference by September 5 to be recognized at event.)

Criteria for NMA 2018 Champions Circle

1. Originators must originate loans in Nebraska, out of state production will be considered, but the home base or branch of the originator must be Nebraska.
2. The Champions Circle will recognize all individuals in following three regions — based on the originators office location – that qualify in the 12 month period specified by NMA Board, as follows:
 - Omaha Metro/Lincoln Metro Areas: 100 Loans OR \$12 million in volume
 - Cities/Towns with population over 15,000 (excluding Omaha/Lincoln Metros): 75 Loans OR \$8 million in volume
 - Cities/Towns with population under 15,000: 45 Loans or \$4 million in volume
3. The originator must submit an entry form **on the NMA website**, confirming their personal loan volume, signed by the originator and branch manager, president or other responsible party. The originator will be required to provide proper verification in the form of a printout of the volume or other acceptable report, verified by the company CFO, president or accountant.
4. The reported production must be the originator's personal business that was a result of his or her referral network and marketing efforts. Originators are not allowed to combine their production figures with those of another originator.
5. The qualification period for 2018 is from August 1, 2017 through July 31, 2018, with information/form submitted to NMA by August 29, 2018. Applications received past the deadline will not receive recognition at the NMA Annual Fall Conference. You must be preregistered by September 5, 2018 to be recognized at the Conference.
6. Individuals must be employed by Nebraska Mortgage Association member firm in good standing.

Criteria for NMA Champions Circle

1. Originators must originate loans in Nebraska, out of state production will be considered, but the home base or branch of the originator must be Nebraska.
2. The Champions Circle will recognize all individuals in following three regions — based on the originators office location – that qualify in the 12 month period specified by the NMA Board, as follows:
 - Omaha Metro/Lincoln Metro Areas: 100 Loans OR \$12 million in volume
 - Cities/Towns with population over 15,000 (excluding Omaha/Lincoln Metros): 75 Loans OR \$8 million in volume
 - Cities/Towns with population under 15,000: 45 Loans or \$4 million in volume
3. The originator must **submit** this entry form **on the NMA website**, confirming their personal loan volume, signed by the originator and branch manager, president or other responsible party. The originator will be required to provide proper verification in the form of a printout of the volume or other acceptable report, verified by the company CFO, president or accountant.
4. The reported production must be the originator's personal business that was a result of his or her referral network and marketing efforts. Originators are not allowed to combine their production figures with those of another originator.
5. The qualification period for 2018 is from August 1, 2017 through July 31, 2018, with information/form submitted **online** to NMA by August 29, 2018. Applications received past the deadline will not receive recognition at the NMA Annual Fall Conference. You must be preregistered by September 5, 2018, to be recognized at the Conference.
6. Individuals must be employed by Nebraska Mortgage Association member firm in good standing.
